**THE BEEKEEPING (GENERAL)(AMENDMENT) REGULATIONS, 2019**

1. These Regulations may be cited as the Beekeeping (General) (Amendment) Regulations, 2019 and shall be read as one with the Beekeeping (General) Regulations, 2005 hereinafter referred to as the “principal Regulations.”

For installation of telecommunication facilities, mineral water extraction facilities, hydropower and large scale irrigation schemes the fee payable per year is 4,416,000/= as establishment fee and 4,025,000/= as Bee Reserve management fees.
